DARTS IS CERTIFIED AS A SPECIALIZED TRANSIT SERVICE (STS) PROVIDER. IN 2019, DARTS USED 6 ACCESSIBLE BUSES TO PROVIDE A TOTAL OF 9,224 TRIPS. RIDERS USE THE BUS TO RUN ESSENTIAL ERRANDS, GET TO CRITICAL APPOINTMENTS, SOCIAL RIDES AS A GROUP. RIDERS REPORT DARTS RIDE SERVICES HELP THEM TO STAY CONNECTED WITH LESS RELIANCE ON OTHER PEOPLE. RIDES ARE PROVIDED IN DAKOTA, HENNEPIN AND WASHINGTON COUNTY, INCLUDING LOOP CIRCULATOR ROUTES IN WEST ST. PAUL, SOUTH ST. PAUL, HASTINGS, LAKEVILLE, EDINA (2), STILLWATER AND COTTAGE GROVE.

DARTS PROVIDES HOUSEHOLD SERVICES THAT ASSIST OLDER ADULTS IN MAINTAINING THE LIFE THEY CHOOSE AT HOME. 95% DARTS CLIENTS REPORT THESE SERVICES HELP TO REDUCE ISOLATION. DARTS STAFF AND VOLUNTEERS PARTNER TO PROVIDE SERVICES THAT INCLUDE HOUSEKEEPING TASKS (INCLUDING LAUNDRY AND MEAL PREPARATION), GROCERY SHOPPING AND ERRANDS, OUTDOOR CHORES (SUCH AS LAWN CARE AND SNOW SHOVELING) AND HOME REPAIRS. IN 2019, DARTS STAFF PROVIDED HOME SERVICES TO 734 OLDER ADULTS. DARTS' LEARNING BUDDIES PROGRAM ALLOWS ADULT VOLUNTEERS TO SHARE THEIR TIME AND KNOWLEDGE WITH ELEMENTARY AND MIDDLE SCHOOL STUDENTS. 95% OF THE VOLUNTEERS REPORT PARTICIPATING MAKES THEM FEEL MORE CONNECTED IN THE COMMUNITY. LEARNING BUDDIES SUPPORTED 4,500 STUDENTS IN 47 ELEMENTARY AND MIDDLE SCHOOLS IN DAKOTA, SCOTT, AND RAMSEY COUNTIES. THE LEARNING BUDDIES PROGRAM TRAINS VOLUNTEERS TO TUTOR AND MENTOR ELEMENTARY AND MIDDLE SCHOOL STUDENTS TO RAISE THEIR PROFICIENCY LEVELS IN READING, MATH, AND SCIENCE. BUDDIES WORK IN 205 CLASSROOMS IN 47 SCHOOLS TO BROADEN STUDENTS' LEARNING SKILLS AND SUPPORT STUDENTS' SOCIAL AND EMOTIONAL LEARNING TO PREPARE THEM FOR THE SELF-MASTERY REQUIRED FOR BECOMING INDEPENDENT, LIFE-LONG LEARNERS.
