WITH FEWER RIDES BEING REQUESTED DURING THE PANDEMIC, DARTS RESPONDED TO THE COMMUNITY NEEDS BY DELIVERING 410 FOOD SUPPORT ORDERS TO OLDER ADULTS IN PARTNERSHIP WITH AREA FOOD SHELVES.**

DARTS STAFF AND VOLUNTEERS PARTNER TO PROVIDE SERVICES THAT INCLUDE HOUSEKEEPING TASKS (INCLUDING LAUNDRY AND MEAL PREPARATION), GROCERY SHOPPING AND ERRANDS, AND OUTDOOR CHORES (SUCH AS LAWN CARE AND SNOW SHOVELING). IN 2020, DARTS STAFF PROVIDED HOME SERVICES TO 490 OLDER ADULTS. DARTS VOLUNTEERS COMPLETED 5,549 SERVICE HOURS ASSISTING OLDER ADULTS WITH YARDWORK, PROVIDING STRATEGIC AND ADMINISTRATIVE SUPPORT FOR DARTS AND READING BOOKS (REMOTELY) WITH ELEMENTARY STUDENTS. 95% DARTS HOME SERVICES CLIENTS REPORT THESE SERVICES HELP TO REDUCE ISOLATION.**

DARTS' INFORMATION AND ASSISTANCE CALL LINE IS THE ENTRY POINT. SERVICE COORDINATORS WORK WITH CAREGIVERS OF OLDER ADULTS TO PROVIDE COUNSELING AND RESOURCE CONNECTION.
