**TRANSPORTATION- DARTS IS CERTIFIED AS A SPECIALIZED TRANSIT SERVICE (STS) PROVIDER. IN 2021, DARTS USED 6 ACCESSIBLE VEHICLES TO PROVIDE A TOTAL OF 7,359 RIDES. WE CONTINUED ASSISTING AREA FOOD SHELF CLIENTS BY DELIVERING 165 FOOD SUPPORT ORDERS TO OLDER ADULTS. LOOP CIRCULATOR ROUTES OPERATE WEEKLY IN COTTAGE GROVE, EDINA, HASTINGS, LAKEVILLE, SOUTH ST. PAUL AND WEST ST. PAUL. WITH DONOR AND PARTNER SUPPORT, WE ARE REFRESHING THE FLEET TO MEET EXISTING NEEDS. TWO TEN-YEAR-OLD BUSES WERE RETIRED, AND TWO NEW WHEELCHAIR CAPABLE VANS WERE ADDED.
