

leveraging community strengths to create solutions for tomorrow.

In 2023, we advanced our strategic roadmap and stayed true to DARTS core values. This resulted in over 5% growth with **excellence** reflected in 99% client satisfaction scores.



DARTS was battling isolation long before the US Surgeon General declared loneliness and isolation an epidemic, and 93% of client responses say they feel less isolated because of DARTS.

Providing **service** to the growing population age 60+ is a priority. We increased home chores capacity in **collaboration** with ProAct, Inc. In partnership with Dakota County and the Community Development Agency, we doubled service navigation support and are now serving 15 senior apartment buildings. Home repairs provided 524 service hours, including repairs for new Washington County clients.

We launched new services which created more **inclusive** ways to connect. The Breathing Space participation has tripled, and in 2024 we are adding more capacity. Latine community members are engaging with our Spanish-speaking staff which improves their ability to access DARTS services and programs. LGBTQ+ community members asked for gathering spaces, and in 2024 that need is becoming a reality. The Learning Buddies and Pen Pals programs have created intergenerational connections for over 25 years and now Tech Buddies adds a new way for young and older adults to connect.



DARTS will continue to grow **responsibly** by building on our existing services, innovating to increase capacity, and using technology to improve our

efficiencies. We are collaborating with community partners to identify gaps in the ever-shifting landscape and providing equitable solutions to create a fulfilling aging journey.


